Applications are invited from eligible candidates to fill up 08 (eight) posts of Stenographers Grade-III (including 01 post of Stenographer Grade-II) on adhoc basis on the principle of equal pay for equal work i.e. Rs.25,500/- (minimum of the pay-scale of the post without any allowances), for a period of six months or till regular appointments are made by Hon'ble Punjab & Haryana High Court, Chandigarh, or, till the regular Stenographers Grade-III become eligible for their promotion to the posts of Stenographer Grade-II, whichever is earlier.

The number of vacancies may increase or decrease due to creation/withdrawal of Courts or otherwise.

**MINIMUM QUALIFICATION REQUIRED:-**

- (a) A person who possesses a degree of Bachelor of Arts or Bachelor of Science or Bachelor of Commerce or equivalent thereto from a recognized university.
- (b) The candidate shall have to pass a test at a speed of 80 W.P.M. in English Shorthand and 20 W.P.M. in transcription of the same on computer. The candidate should have proficiency in operation of computers (word processing and spread sheets).

**AGE LIMIT**

The minimum age shall be 18 years and the upper age limit shall be 42 years as on 01.01.2024.

**DATE AND TIME OF SHORTHAND TEST:**

Shorthand test shall be conducted in Judicial Courts Complex, Sector-17, HUDA, Jagadhri, Distt. Yamuna Nagar on **26.05.2024 (Sunday) from 10:00 A.M.** onwards.

The list of eligible/non-eligible candidates will be uploaded on the official website of this Sessions Division on or before 25.05.2024. All the eligible candidates should reach the Judicial Courts Complex, Sector-17, HUDA, Jagadhri, Distt. Yamuna Nagar on scheduled date i.e. **26.05.2024 (Sunday) by 08:30 a.m.** positively. No separate call letters will be issued.

If on verification, at any stage, before or after the test, it is found that an applicant does not fulfill any of the eligibility criteria, his/her candidature shall stand canceled without any notice.

- vii) No TA/DA will be paid to any applicant for appearing in the test.
